RE: 2011 Campus Safety and Security Survey

Attached to this document you will find our 2011 campus crime report as reported to the U.S. Department of Education for the twelve month period beginning October 2011 - September 2012. The information listed in the report is compiled in accordance with the provisions of the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act. As required by law, this statement, and the Campus Safety and Security Survey shall be distributed to all students by October 1, 2012. These documents will also be published to the college website.

This report includes statistics for the previous two years concerning reported crimes that occurred on campus; in certain off-campus buildings or property owned or controlled by Trenholm State Technical College; and on public property within, or immediately adjacent to and accessible from either campus. The report is compiled from local college sources and data from the City of Montgomery Police Department for 2011. The Montgomery Police Department did not publish their typical annual report for 2011.

Trenholm State Technical College properties are as safe as any institution within the metropolitan area. As indicated in the attached report, there have been no significant crimes committed on or near our campuses. As with previous years, we continue to report theft of college property that meets the reportable guidelines of the Clery Act.

The loss of college property is a multi-dimensional problem that has much to do with economic pressures in the community and ease of access to college resources as result of having open campuses. Last year we reported 2 larceny thefts occurring in 2010. For this 2011 reporting period, we had 2 reportable theft events although we had several vehicle break-ins, fuel stolen from our truck driving program, metal stolen from our welding program, and a LCD projectors removed from the video teleconference room on the Patterson campus. These events are not reportable because they were not the result of any forcible entry into a building.

For the 2012 Campus Safety and Security Survey next year, we will report the loss of nearly \$50k in metal from the Welding program, our grounds maintenance shed was breeched and nearly \$30k in commercial lawn equipment was stolen and more than \$30k in automotive diagnostic equipment was stolen from the automotive program. Forcible entry was a factor in at least one of the events. A college vehicle was demolished by vandalism as well as many windows have been broken in college buildings. Much of the vandalism was conducted by teenage children in the local area surrounding the Patterson campus.

To slow this activity, we have implemented changes to limit access to the campuses afterhours, continued expansion of video surveillance both inside and outside of our buildings as well as building a stronger relationships with local law enforcement agencies. As a result of working closer with law enforcement, most of the equipment that was stolen this year has been returned. This investigation is still underway and we hope to get all of the missing equipment back.

Further, city crime statistics (Attachment 2) indicate Montgomery police department's implementation of a precinct patrol system which places law enforcement in the community has had an effect on criminal activity overall. In each of the categories in the districts where our campuses are located the numbers are at least 30% lower from the previous year.

Providing a safe environment for learning is the responsibility of every employee. It is your continued vigilance and zero tolerance for disruptions to college business that enables the college to report its strong safety posture.
