RE: 2012 Campus Safety and Security Survey

Attached to this document you will find our 2012 campus crime report as reported to the U.S. Department of Education for the twelve month period beginning October 2011 - September 2012. The information listed in the report is compiled in accordance with the provisions of the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act. As required by law, this statement, and the Campus Safety and Security Survey shall be distributed to all students by October 1, 2012. These documents will also be published to the college website.

This report includes statistics for the previous two years concerning reported crimes that occurred on campus; in certain off-campus buildings or property owned or controlled by Trenholm State Technical College; and on public property within, or immediately adjacent to and accessible from either campus. The report is compiled from local college sources and data from the City of Montgomery Police Department for 2012. The Montgomery Police Department did not publish their typical annual report for 2012.

Trenholm State Technical College properties continue to be safe as any institution within the metropolitan area. As indicated in the attached report, there have been no significant crimes committed on or near our campuses. As with previous years, we continue to report theft of college property that meets the reportable guidelines of the Clery Act.

The loss of college property continues to be an ongoing problem for Trenholm. This report contains one reportable burglary event that was mentioned in last year summary. We reported the loss of nearly \$50k in metal from the Welding program, our grounds maintenance shed was breached and nearly \$30k in commercial lawn equipment was stolen and more than \$30k in automotive diagnostic equipment was stolen from the automotive program. Forcible entry was a factor in at least one of the events. *It is important to note that all but one piece of the stolen equipment was returned to the college through an intense investigation by the Montgomery Police and Wetumpka Police Departments.* A college vehicle was demolished by vandalism as well as many windows have been broken in college buildings. Much of the

vandalism was conducted by teenage children in the local area surrounding the Patterson campus.

Specific measures the college has taken in the last twelve month to mitigate the theft has been the expansion of surveillance systems throughout the Patterson campus and Library. Beginning this upcoming fiscal year we will expand interior and exterior surveillance on the Trenholm Campus.

Further the college has awarded a new security guard contract with DSI Security whom will transition into duty on October 7, 2013. The college has also entered a contract with Montgomery Police Department to provide security services on the Patterson campus on weekends and holidays.

The City of Montgomery crime statistics (Attachment 2) indicate some remarkable increases in criminal activity around both campuses. Montgomery police department has implemented a precinct patrol system and recently announced a new precinct location in the Montgomery Mall which will enhance the safety and response of the police force around the Patterson campus.

Providing a safe environment for learning is the responsibility of every employee. It is your continued vigilance and zero tolerance for disruptions to college business that enables the college to report its strong safety posture.
